Any organisation or individual who makes representations on the Draft Charging Schedule may withdraw those representations at any time by giving notice in writing to the Council, sent to the specified addresses as detailed above.

Any organisation or individual may request the right to be heard at the subsequent Examination of the draft CIL Charging Schedule. This request must be submitted in writing and received within the specified consultation period between 14 December 2022 and 25 January 2023.

Representations may also be accompanied by a request to be notified, at a specified address, of any of the following:

- That the Draft Charging Schedule has been submitted to the examiner in accordance with Section 212 of the Planning Act 2008.
- The publication of the recommendations of the examiner and the reason for these recommendations, and
- The approval of the Charging Schedule by the Council.
