

# Exeter Community Infrastructure Levy (CIL) Consultation: Draft Charging Schedule

14 December 2022 – 25 January 2023

The CIL is a charge paid to the City Council by some forms of new development when it receives planning permission. The funding received by the Council is invested in infrastructure and community services to make sure that the impact of new development is managed appropriately. The Council already operates with a CIL but the rates were set back in 2013 and so need to be reviewed. These proposed CIL rates are set out in a revised Community Infrastructure Levy Draft Charging Schedule.
